- By signing this form, **you (the authors or other copyright owner) agree** to grant the publisher, I.N.C.D.B.N.A., the exclusive right to publish and distribute / sell worldwide your article (abstract included) in hard copy, electronic or any other form, and in turn to authorise third parties (including Reproduction Rights Organisations such as the Copyright Licensing Agency and the Copyright Clearance Center) to do the same. - **You affirm** there is no **Conflict of Interest** related to your article. A conflicting interest exists when professional judgement concerning a primary interest (such as patient's welfare or the validity of research) may be influenced by a secondary interest (such as financial gain or personal rivalry). This may arise when the authors have financial interests that may influence their interpretation of own results or those of others.
